

## 2025 LWVOR Program Planning: Existing Programs

### EXISTING PROGRAMS

When reviewing the current program, members should consider whether to retain, drop, update, or restudy existing positions as defined below.

**RETAIN** means keep position as currently written, with no change.

**DROP** means to remove the position completely from the position portfolio. All further advocacy on the topic will be discontinued. It may not again be incorporated into the program without completing a new study.

**UPDATE** means to study the position topic for informational purposes only, with no intention to update the position, only to update the knowledge base for the members.

**RESTUDY** means to undertake a review of the position in order to potentially change it.
